ANTI-CORRUPTION COMPLIANCE STATEMENT

DETROIT S.A and/or its subsidiaries and/or related companies require, within their values, high standards of compliance of anti-corruption practices, to all its employees, managers, shareholders, and partners, for which they require all its clients, providers, parties and third parties involved in trade operations, whichever it is, to always act ethically and in good faith when providing services, making sales and complying with all contractual obligations with Detroit S.A. For that purpose, the company requires the compliance of all laws in force applicable to that matter.

The company states the compliance of the world legislation against corruption and bribery, such as Foreign Corrupt Practices Act, FCPA, UK Bribery Act, 2010, Criminal Liability of Legal Persons Act (Act 20.393, Chile), and all other similar acts regarding anti-corruption behaviors.


Current anti-corruption regulations prohibits DETROIT S.A. and/or any of its subsidiaries and/or related companies, as well as any person, natural or legal, working in its representation, to offer, promise and/or pay any kind of money or valuable things to any person with the purpose of obtaining economic benefits, handouts or retaining a business involving the company that are irregular or illicit.

Pursuant to the foregoing, you state:

- 1.- I, by myself and, on behalf of the company, and of any person hired by the undersigned or by my company, know and understand the Detroit S.A. and/or its subsidiaries and/or related companies policies regarding the compliance of the anti-corruption laws. I state that I will comply with all the applicable laws, both national and international, regarding anti-corruption, at all times as long as there is any relationship, whether it is contractual, commercial or dependent in all business activities I carry out for or with DETROIT S.A. and/or its subsidiaries and/or related companies.

I agree and understand that any violation of the abovementioned and existing laws about this issue will result in the immediate termination of all contracts and/or agreements entered into with DETROIT S.A. and/or its subsidiaries and/or related companies with no additional payments, provision of funds or any indemnity.

- 2.- I state that I do not have the knowledge of any kind of offering, payment, promissory payment or payment authorization of any amount of money, nor of any offer, gift, promise to provide or authorization to provide anything of value that have been made or offered directly or indirectly to a government official, employees of a government company, political parties, or to any candidate for a public office, or to any person, whether it is on the commercial side or its employees, knowing that all or part of the money or the valuable object will be offered, provided or promised, directly or indirectly, to obtain economic benefits, retain a business that are irregular or illicit, or payments, with the purpose of being

beneficiary of laws, regulations or certificate in the interest of DETROIT S.A. and/or its subsidiaries and/or related companies.

- 3.- I state that I do not have any conflict of interest in my relationship with DETROIT S.A. and/or its subsidiaries and/or related companies, whether they are friends, family or people related to me that could benefit from the business relationship with DETROIT S.A. and/or its subsidiaries and/or related companies. Me, my company and any person hired by me or my company do not have any family member that is a government official or candidate for a political party that may influence in the business relationship with the clients of DETROIT S.A. and/or its subsidiaries and/or related companies.

- 4.- I state and give my consent on providing DETROIT S.A. and/or its subsidiaries and/or related companies all information related to the payments made by me or on behalf of this company, or by any person of my company, that may carry out any role or service for DETROIT S.A. and/or its subsidiaries and/or related companies, additionally binding me to report all events that may constitute an illicit benefit for DETROIT S.A. and/or its subsidiaries and/or related companies or for the company it hires with it with a violation of the current regulation that eradicates all actions or omissions from those corruption practices.
